



### Announcement of Chiang Mai Primary Educational Service Area Office 3

According to a policy of the Prime Minister (General Prayuth Chan O Cha) given on September 12<sup>th</sup>, 2014, about promoting government administration with ethics and prevention of corruption and government misconduct, the Civil Service Ethics Code 2009, the OBEC regulation manual of Civil Service Ethics Code of OBEC government officers 2009, the Civil Service Ethics Code of Civil service Commission of OBEC, Announcement of OBEC on June 22, 2011: Policy of Transparency and Accountability and the Integrity and Transparency Assessment (ITA) of the Office of the National Anti-Corruption Commission (NACC) and the Office of Public Sector Anti-Corruption Commission (PACC),

  - 5.4 Cooperate on informing the national strategy about preventing and vanquishing corruption phase 3 (2018 – 2021), especially ways of promoting ethics, to the Area Office 3 boards, School directors, as well as government officers and personnel in the

Chiang Mai Primary Educational Service Area Office 3 who are part in every level of OBEC education to build up knowledge, understanding and participation on spreading out knowledge to youths, parents and other people to participate preventing and vanquishing corruption activities and to be part of the anti-corruption network.

5.5 Collaborate on giving knowledge about monitoring and checking on prevention of corruption to government officers and personnel in the Area Office 3, such as assistant director of the Area Office 3, all directors of working units, school directors, all government officers and personnel contributing education to create understanding and participating in joining anti-corruption activities to build up knowledge, understanding and participation on spreading out knowledge to youths, parents and other people to participate preventing and vanquishing corruption activities and to be part of the anti-corruption network.

5.6 Collaborate on creating ethics and transparency indications for government units under the OBEC and work on as planned according to the national strategy about preventing and vanquishing corruption phase 3 (2018 – 2021).

5.7 Collaborate on contributing pathways to publicize and communicate to support the operation as one of the anti-corruption network.

5.8 Collaborate on consulting, giving advices, including following ups and evaluating the so called operation.

5.9 Collaborate on all other kinds of prevention with full strengths and potentials.
